A. Firearms

a. The lifecycle for duty weapons for the Police Department is 5 years. The department is currently slightly over that 5 year mark. Due to the safety concerns of the Sig Sauer P320's, which is currently the duty weapon of the officers here, the police department would like to update their weapons and switch manufacturers. Sgt. Meyers presented the Police Commission with a plan to move away from the Sig P320's and to a Glock 45 safety action pistol. Due to many federal agencies and police agencies across the country banning the use of the Sig P320's, the Police Department would like to move

forward with the purchasing of the Glock 45 Safety Action Pistols for the safety of the officers. Commission Obertanec made a motion to approve the purchase of the new weapons immediately with 2025 salary funds and Commissioner Siede seconded the motion. All were in favor. This presentation will also be brought to the next selectmen's meeting so they are aware we will be using 2025 funds for this purchase. The new weapons will cost \$18,295.04 for all equipment related to this Glock 45.
